Altru Health System in Grand Forks, ND, presented its annual Nursing Hall of Fame Award to Oncology Nursing Society (ONS) member Nancy Klatt, RN,

a manager at Altru Cancer Center. The award is given annually to nurses who, over the course of their career, have exhibited extraordinary achievement in nursing at Altru. Klatt is the 19th recipient of the award.

A nurse at Altru Health System since 1976, Klatt has shown continuous dedication to the system, its patients, and employees through her focus on oncology services. MD Anderson Selects Outstanding Nurse Oncologist



Nancy Tomczak, RN, OCN®, a clinical nurse in the inpatient stem cell transplantation unit at the University of Texas MD Anderson Cancer Center, received

the 2011 Ethel Fleming Arceneaux Outstanding Nurse-Oncologist Award, presented by the Brown Foundation, Inc. A committee of MD Anderson's clinical faculty, patient-care administration, and nursing staff reviewed nominations sent from peers and patients alike before selecting Tomczak as the choice for the annual award. Established by the foundation in 1982, the award is the institution's highest nursing honor.

"I'm so honored by this award," said Tomczak. "I'm truly overwhelmed."

At age 8, after witnessing her grandmother succumb to lung cancer, Tomczak made it her mission to help fight cancer. Her passion increased after surviving a life threatening car accident at age 16.

"Were it not for the care of the dedicated healthcare workers at my bedside, I could have easily fallen into a black hole of self-pity," she said.

A graduate of the School of Nursing at the University of Texas Health Science Center at Houston, Tomczak has spent her entire 10-year career at MD Anderson. She has proven herself not only as a nurse, but also as a leader. She has been an active member of ONS and serves as chair of the Nursing Practice Congress.

The greatest gift that nursing has provided Tomczak is the impact that patients have in turn had on her life. As she seeks to make a difference in the lives of her patients, she said, they ultimately make a difference in hers.

"I repeatedly tell others how my job is almost selfish," she said. "I get more from my patients than I could ever offer them. . . . They teach me life lessons, expose me to cultures I never imagined knowing, and help me to appreciate each breath I take."

The University of Texas MD Anderson Cancer Center in Houston ranks as one of the world's most respected centers focused on patient care, research, education and prevention. MD Anderson is one of 40 comprehensive cancer centers designated by the National Cancer Institute.

Leading Cancer Nurse Joins Emory University



Deborah Watkins Bruner, PhD, RN, FAAN, an internationally recognized authority on cancer care and quality of life, has been appointed to the faculty at Emory University in Atlanta, GA. Bruner will hold a dual appointment as a professor of nursing at Emory's Nell Hodgson Woodruff School of Nursing and as associate director of cancer outcomes at the Winship Cancer Institute of Emory University.

Bruner formerly was the Independence Professor in Nursing Education at the University of Pennsylvania in Philadelphia. She is best known for her pioneering leadership within the National Cancer Institute (NCI)-supported Radiation Therapy Oncology Group (RTOG). She is the first and only nurse to lead one of NCI's national clinical community oncology programs research bases and is RTOG's Vice Chair for Outcomes. Bruner also is a member of the NCI Clinical Trials Advisory Committee, which helps set the national cancer clinical trials research agenda, and cochairs NCI's Symptoms Management Steering Committee.

"Dr. Bruner is one of the nation's pre-eminent researchers in oncology nursing," said Linda McCauley, PhD, RN, FAAN, FAAOHN, dean of Emory's School of Nursing. "Emory University is fortunate to have this outstanding scholar working to continue our tradition of world-class research and to foster collaborations between the School of Nursing and the Winship Cancer Institute."

Bruner has devoted her research to improving outcomes for patients with cancer. Her areas of focus are quality of life and symptom management across cancer sites, as well as decision-making preferences and utilities for cancer therapies. Currently, Bruner is leading three National Institutes of Health studies and one NCI clinical trial. Her research has been published in a number of journals, including the *Oncology Nursing Forum*.

Patient Advocate Foundation Expands Lung Cancer Programs

A charitable donation made by Lilly Oncology will enable the Patient Advocate Foundation (PAF) to expand its patient services programs, including the Case Management and Co-Pay Relief (CPR) Programs for patients with non-

squamous non-small cell lung cancer, the most common form of lung cancer.
