

Reference and Citation Format

ONS uses the American Psychological Association (APA) style for references and citations. For more detailed information, refer to the Publication Manual of the American Psychological Association (7th ed.).

All references should be alphabetical. Be sure to cite each reference used within the text in the reference list. Also, check that you have used each reference appearing in the final list in the text. If you are unsure about how to cite a reference, include all possible information that may be needed. Compiling reference information on index cards or in an electronic reference manager can be useful to keep track of them. It is better to have the information on hand than to go back and track down the information when you are ready to compile your reference list.

Note. When formatting references, list entries have a hanging indent. ONS style does not include spaces between author initials.

Two authors	<ul style="list-style-type: none">• Untreated depression can have a significant impact on the quality of life and symptom distress in patients with advanced cancer (Bowers & Boyle, 2003).• Bowers and Boyle (2003) found that . . .
Three or more authors	<ul style="list-style-type: none">• APA style now only includes the first author plus “et al.” for more than two authors.• (Jones et al., 2012)• Jones et al. (2012) found that . . .
Same first author in multiple references with the same year	<ul style="list-style-type: none">• If multiple references have the same first author and same year but different subsequent authors, include the second author.<ul style="list-style-type: none">– (Jones, Cleves, et al., 2012)– (Jones, Davis, et al., 2012)• Or include authors until there is a difference in listing.<ul style="list-style-type: none">– (Jones, Cleves, Wilt, et al., 2012)• (Jones, Cleves, Davis, et al., 2012)
Different authors with same surname	<ul style="list-style-type: none">• If different first authors have the same surname, include initials in the citation, even if the references have different dates or multiple authors.<ul style="list-style-type: none">– (G. Davis, 2013)• – (B.H. Davis & Foster, 2015)

Table and Figure Citations

If someone else’s material has undergone substantial alterations for use in another publication, it has been adapted; if no changes, or only minor changes, have been made, it is being reprinted.

Both cases require permission, and proper credit should be given to the author/publication holding the copyright (see also **Requesting Permission to**

Reprint document).

If one or more references were used to compile a table, the references should be noted at the bottom of the figure or table as a footnote using the following format:

Note. Based on information from Brickman & Karuza, 1987; Ferrell, 1986. (Always use “et al.” for references with three or more authors in “based on” lines.)

Permission for adapting/reprinting tables and figures: Generally, follow APA style regarding the content and format of reprinted or adapted with permission lines. However, if the copyright holder specifies content to include that does not comply with APA style, then be sure to incorporate it somehow. The format of the permission line should still adhere to APA style as closely as possible. (Copyright holders are much more concerned about the content than the format of permission lines.) See APA Tables 12.1 and 12.2. See the following examples for common sources of tables/figures.

The caption for a table/figure reprinted from a book follows this format:

Note. From *Book Title* (nth ed., p. xxx), by Author(s), Year, Publisher. Copyright 19xx by Copyright Holder. Reprinted (or Adapted) with permission.

Example for a chapter in an edited book:

Note. From “An Understanding of Suffering Grounded in Clinical Practice and Research,” by D.L. Kahn and R.H. Steeves, in B.R. Ferrell (Ed.), *Suffering* (4th ed., p. 20), 1996, Jones and Bartlett Learning. Copyright 1996 by Jones and Bartlett Learning. Reprinted (or Adapted) with permission.

Adaptation/reprint information pertaining to a figure or table should not appear in the reference list unless it is also cited somewhere in the text.
